I am writing this letter in enthusiastic support of the Tilly Life Center (TLC). I have worked with Tilly Levine and her staff for the last three and a half years. As a faculty member in the School of Education, at the University of California, Irvine, I have taught an Ethics and Education class for undergraduates for the last 17 years. Through that time, I have searched for programs that bring theory into practice and make character development a real possibility. I found one such place.

In the fall of 2016, a TLC professional and I taught UCI undergraduate students the TLC "I am Me" program. Each student experienced the various life skill lessons such as "I am Forgiving", "I am Kind", "I am Authentic", "I am Myself", et al. We lived the program. I was amazed and inspired of the instant impact on our class and on each individual. In a mere 10 weeks, we began building true community in which shy students opened up and confided in their classmates as we journeyed together through personal discoveries and vulnerable moments. When I read the student's final paper reflecting on their experience with the TLC program it became consistently evident that their personal growth was profound, and their introspection was genuine and significant. Many claimed it was their finest academic experience precisely because it felt "real" as opposed to simply studying new knowledge. It was a deep, ever questioning self-discovery with the ultimate result of fostering new behaviors to create a better self, and in turn a better community...world.

In the following academic winter quarter these same students worked in high school settings where they assisted TLC facilitators in delivering the program to teenagers. Again, their experience was profound and valuable. Moreover, our UCI students have direct experiences that relate to their major: education. Connecting to students, building rapport, and leading younger students while inspiring these teenagers to college possibilities serve both age groups. Overall, our UCI students were grateful, touched, and felt the value of the TLC program from an educational and personal perspective. Recently, after this pilot tested class was completed and its effectiveness thoroughly evaluated, UCI has approved the class as a permanent part of our School of Education.

This past fall of 2018, I led the UC Irvine class (with a TLC staff member assisting). I felt comfortable teaching the TLC curriculum, and the evaluations for the class were very high and far above the university average. I plan to keep teaching this class each Fall quarter.

On both a professional and personal note, I have found the TLC staff to authentically embody the spirit and the purpose of their program. As I have worked and socialized with them, it is evident that each person on this staff evokes an attitude of caring, thoughtfulness, and moral responsibility toward their mission. They not only "practice what they preach", but do it in such a joyful and contagious spirit. It has fueled me in my own daily work towards fulfilling both my academic and personal motivations to simply make a contribution to this critical subject matter.
